CLUB SPORT PARTICIPANT ASSUMPTION OF RISK & LIABILITY RELEASE

To be completed by September 30th, 2010 or before first date of play and submitted to the Club Sports Office.

This is a legally-binding Release made by me, _____ (and/or my legal guardian), to the _____ Team (hereby referred to and defined as "TEAM"), and the University of Connecticut, regarding my membership on said team during the period of August 1, 2010 to May 31, 2011.

As a member of the TEAM, I fully recognize that there may be direct, indirect or inherent risks and hazards involved in these activities and it is with full knowledge of the facts and circumstances surrounding this activity and to the extent permitted by the laws of the State of Connecticut, that I release this TEAM and the University of Connecticut, its members, officers, employees, agents and representatives from any liability whatsoever arising out my participation in this activity. **These Risks include but are not limited fractures, broken bones, concussions, bruised, sprained, and torn muscles and ligaments.** I also understand that I am not required to participate in this activity by the TEAM or the University of Connecticut, but that I want to do so on my own free will, in recognition of the possible danger and risks.

I assure the TEAM and the University of Connecticut that there are no health-related reasons or problems which preclude or restrict my participation in this activity and that I have adequate health insurance necessary to provide for and pay for any medical costs that may directly or indirectly result from my participation in this activity. I also assure the TEAM and the University of Connecticut that I am in the requisite mental and physical health to participate in this activity and will not endanger other participants.

In consideration of and return for the services, facilities, and any other assistance provided me by the TEAM and the University of Connecticut in this activity, it is my express intent to indemnify and hold the TEAM and the University of Connecticut and its representatives harmless, herein releasing the TEAM and the University of Connecticut and its representatives from any and all liability, claims and/or actions that may arise from injury or harm to me, either from my death or from damage to my property in connection with this activity. I also agree to assume all of the risks and responsibilities in any way associated with this activity and understand that this Assumption of Risk and Liability Release shall bind the members of my family and spouse, if I am alive, as well as my estate, family, heirs, administrators, personal representatives or assigns, if I am deceased and shall be deemed as a "Release, Waiver, Discharge and Covenant" not to sue the above-named TEAM or the University of Connecticut. I further agree to save and hold harmless, indemnify and defend the TEAM and the University of Connecticut from any claim by my family, or me arising out my participation in the activity referenced herein.

If any term of this Release shall be held illegal, unenforceable, or in conflict with any law governing this Release, the validity of the remaining portions shall not be affected thereby.

Any action, arbitration or mediation arising out of my participation on the TEAM will be governed by the state of Connecticut Laws. I further state that I am at least eighteen (18) years of age and fully competent to sign this Agreement and that I execute this release for full, adequate, and complete consideration, fully intending to be bound by the same.
